September Plenary: CSU San Marcos

The last CSSA plenary that took place was in September at CSU San Marcos. It went very well, and you can find the details of this plenary in my latest plenary report that was emailed to you on 9/25.

Here are the main takeaways:

- I was elected Vice Chair of the Legislative Affairs Committee
- Chancellor's Office presented the 4th Year Quantitative Reasoning Requirement to us and acknowledged that they had bad data
 - CSSA Board Members generally oppose this requirement
 - Has been tabled and we have yet to vote on it
- Two federal bills in CSSA's focus right now: The Basic Act by Senator Harris and the College Transparency Act by Senators Cassidy, Warren, Scott, and Whitehouse
 - Both tabled until next meeting
- Two more staff turnovers: Jared Giarrusso (head of Governmental Affairs – Sacramento Office) & Cecelia Koger (Senior Manager of Finance & Administration)
 - So now, CSSA's personnel committee and remaining staff are looking to replace an Executive Director in addition to these two positions

- Brandon Tsubaki is now the Interim Executive Director

October Plenary: Fresno State

The next CSSA plenary will be at Fresno State from October 19th-20th.
