This month we also passed a Resolution in Opposition to the proposed 4th year of Quantitative reason requirement for CSU Admission. I along with our President, took the lead on authoring and passing the resolution, and our OGA team has been hard at work with our advocacy since it was passed. Learning the process of legislation that was not passed unanimously was valuable to our board and I see us gaining the ability to have more in-depth discussions in the future because of the experience.
