University Committee Updates

Faculty Senate Executive

- Faculty Senate Exect meets EVERY Tuesday from 3-5pm. Faculty Senate Exect works to prepare and condense information for Faculty Senate. Our main discussion for the past few weeks has been Bill AB928. AB928 is a bill passed by the state requiring ALL community colleges, UC's and CSU's requiring all schools to have ONLY 34 General education requirements. This requires Sac State to cut 6 units. This committee alongside with Faculty Senate and GE/Graduation requirements committee have been working together to come to a consensus.
- Other topics have been about campus wide issues such as program proposals and faculty committee appointments.
- General education and graduation policy committee came out with a resolution about the legislature interfering with CSU'S academics and AB928.

Faculty Senate

- Faculty Senate meets EVERY Thursday from 3-5pm. Faculty Senate main discussion has been about Bill AB928 and what stance should Sac State take.
- On the Oct. 20th meeting, Sac State faculty senate had to give their decision on their stance on AB928. Myself and along with other students came to the meeting and spoke on why should faculty vote in favor for the ICAS

recommendation. Around 7 students spoke and faculty read the ASI resolution in favor of the ICAS recommendation.

- After long debate, the senate voted in favor with the ICAS recommendation.
- Oct 3rd meeting discussed the sexual assault cases that have been arising and President Nelsen, Vp of Student Affairs, Ed Mills and Provost, Carlos Nevarez spoke on what they're doing to keep students safe.

Strategic Priority Updates

2.2.2 (Explore placing permanent link on portal, My Sac State, for basic needs)– Scheduled a meeting with BOD on Sept 26th at 4pm to discuss our plan moving forward with this priority. I sent an email to the Director of IRT, Mark Hendricks with BOD cc'd in email. I talked with Mark and he out in the official request WCAP Board. I submitted required documents and the WCAP Board asked me to present to their board about the portal on Oct. 12th at 3pm. Then, the board will decide if they will move to approve our request.
