Internal Committee Accomplishments

Student Academic Senate

The Student Academic Senate shall serve in an advisory capacity to the Board of Directors about matters within the Faculty Senate and Academic Affairs that directly affect students. During the fall semester, I did something new with the committee. I divided the committee into subcommittees for the members to pick and choose what they are most interested in focusing on for the rest of the semester. During the spring semester, I decided to invite administrators/faculty to our student spaces to hear from students directly instead of it coming from the ASI VPAA acting as a liaison. The SAS members enjoyed the new format for the committee.



We focused on increasing faculty salary, increasing cultural diversity on campus, affordable student housing, and student basic student needs during the fall semester. Spring 22 semester, we discussed the role/struggle of student housing on academics, discussed the housing survey results presented by Samuel Jones, discussed class modality, pros, and cons of in-person and virtual classes, discussed course workload, the courses with the most drop, withdraw, and fail (DFW) rates, suggested ideas for events to bridge the gap between students and administration, and reflected on the committee meetings of the semester.

University Committee Accomplishments

Faculty Senate

The Faculty Senate is the primary consultative body for instructional and academically related professional matters on campus.

There were many things we discussed within the Faculty Senate. For the Fall semester, we mainly discussed the Racial Bias Incidence Tool. The Racial Bias Incident Reporting Form serves as an educational tool to promote a community where individuals can share their perspectives and engage in civilized discourse across differences.

We discussed the five-year Strategic Plan, ASI Resolution in Support of SB 641, update on transfer credit evaluations, update on safety measures associated with parking at night, and policy on the transportation of sick and injured individuals on campus, amongst other issues. I highly encourage you to go through all my previous monthly board reports to see what was discussed.

Faculty Senate Executive

The executive committee of the Faculty Senate is responsible for setting the agenda of the Faculty Senate, among other duties. Most of the meetings we had in executive pertained to items we would eventually discuss in Faculty Senate.

2.2.1 Advocate for student wellness regarding COVID-19

Promoted COVID-19 safety guidelines to the campus community via social media. Hosted at least one event to promote student wellness regarding COVID-19. Met with Student Health & Counseling to determine the best ways to advocate for student wellness regarding COVID-19. I gave out COVID test kits during the Pop-Up pantry, other members met with SHCS, and we all promoted flyers on our social media.

All Executive Board members conducted an individual review of their Operating Rules. At least two (2) college directors undertaken a study of the College Director Operating Rules.

My Operating Rules did not require changes since the previous VPAA updated them.
