As I begin my second year as the President's Designee to the Board, I want to welcome each of you to the 2021-22 school year and let you know how excited I am to be able to serve our students alongside each of you in this critical and challenging year. It is so exciting to see students back on campus, but it is clear to me not everyone is ready to make the return to the inperson experience. I am hopeful we can work collectively to support those students who wish to remain in a virtual space as well as those who grace our campus each and every day. I am excited to share updates with you, and I hope I am able to provide information that can be insightful and helpful to you. In that light, I would like to share of a couple of updates with you which you may find informative:

*Enrollment:* As of Sept. 13, 2021, Sacramento State's total headcount (HC) is at 31,834 enrolled students That number is above our total from fall semester of 2020 on this same date (31,678 HC) and is ahead of predictions from earlier this summer.

*Crisis Assistance & Resource Education Support (CARES):* The CARES team has been working at an extremely high level this past year in an effort to support our fellow Hornets who have been affected by the continuing pandemic.
