# **IV. NEW BUSINESS:**

### A. Appeal of Strike #1

- The case of the first strike was presented by the Executive Vice President to the ASI Executive Committee.
- The EVP stated the purpose of the first strike as the violation of Operating Rule #15, failure to conduct oneself in a professional manner.
- The EVP stated that this is referring directly to an interaction between the Vice President of University Affairs and the University Union custodial staff when the VPUA entered the University Union on Tuesday, June 13th 2023 at exactly 11:26pm. The interaction consisted the staff questioning the VPUA presence in the Union so late in the evening to which the VPUA responded something along the lines of "I can come and go as I please. I work here and I can do what I want."
- The Executive Director reminded that all ASI Board members need to be role models as student leaders and it is a privilege that can be taken away.
- The Vice President of Finance stated that it is a privilege to hold these positions and that it's normal for the custodial staff to ask what we're doing.

### APPEAL NOT PASSED (3-2 vote); STRIKE #1 REMAINS AS ISSUED

#### **B.** Appeal of Strike #2

- The case of the second strike was presented by the Executive Vice President to the ASI Executive Committee.
- The EVP stated the purpose of the second strike as the violation of Operating Rule #15, failure to conduct oneself in a professional manner.
- The EVP stated that this is referring directly to incidents where the Vice President of University Affairs entered the Hornet Wrap Up Event in the University Ballroom and helped himself to food that was intended for incoming students and guests. Despite being told that this was no acceptable, the VPUA continued to consume the food was not for him to take.
- The Director of the New Student Orientation contacted ASI to report the behavior.
- The Vice President of University Affairs claimed that this was completely false and that he was only given one warning. The VPUA stated that he did go in three times but was only told once he can't go in and didn't go anymore after that. The VPUA stated that he thought the food was for everyone.
- The Executive Director stated that the Director of the New Student Orientation has been here for a very long time and that she has never found the Director of the New Student Orientation to be dishonest. The Executive Director mentioned that the email she received was very sharp and that she doesn't receive emails like that.
- The Vice President of Academic Affairs stated that the VPUA needs to be more welcoming and take more responsibility for his actions now that he's a public figure.
- The President stated that the VPUA is a board member and that he must keep that in mind everywhere he goes. The President stated that we all know that this is not the first time and that we've been told that the VPUA has an unprofessional tone.
