Information about suspended programs:

I wanted to address some concerns raised by graduate students regarding the suspension of programs. Specifically, there have been questions about the lack of advance notice prior to these suspensions. I would like to provide some clarification on the process: departments make decisions about suspending programs based on several factors, such as enrollment, class availability, student interest, and funding. While departments have their own budget and resources analysts, the decision to suspend a program is made internally, and it does not involve seeking permission from the ASI Graduate Representative.

When I inquired with the Office of Graduate Studies (OGS) about the suspension of specific programs, I learned that they do not have a comprehensive list of suspended programs. Additionally, it appears that the suspension of a program could vary in duration—whether for a semester, a year, or indefinitely—and departments may not have a clear estimate as to when the program may be reinstated. It seems that OGS may not always be informed of specific details regarding program suspensions, class availability, course load limits, or graduation requirements, as departments have some flexibility in determining their own policies in these areas.

My primary liaison is with the OGS, and I rely on them to relay information regarding any program changes, which I can then pass along to the graduate student body. I have made every effort to stay informed and conducting my own research, including reviewing the graduate admissions site and speaking to students to track any program suspensions.

Based on my findings, the following graduate programs are currently suspended:

- MS in Software Engineering
- Criminal Justice
- Executive MBA
- Doctorate in Education

Please rest assured that I am actively addressing any issues I come across with OGS and other relevant bodies, such as the Graduate Student Policies Committee. I would also like to note that, in my role as the graduate representative, I have faced personal and professional challenges such as retaliation when advocating for graduate students, which has been quite distressing. However, I remain committed to my responsibility of supporting and representing the graduate student community. While the direct impact of my efforts may not always be immediately visible to all, I encourage anyone with concerns to reach out to OGS for confirmation of the advocacy I am undertaking on behalf of graduate students.
