Student Health, Counseling, and Wellness

Efforts to improve student health and wellness include:

- Hiring of two additional licensed counselors
- Hiring of a part-time (20-hour/week) psychiatrist
- Introduction of ADHD testing services
- Signing of the Timely Care contract
 - Marketing rollout for Timely Care services in progress
 - New service to provide students with comprehensive care, including after-hours, weekend, and holiday access to licensed therapists and medical doctors

Basic Needs Initiatives

- Construction of the Basic Needs Center is complete
- Recruitment for a Basic Needs Coordinator is underway
- Partnerships with community donors and the Foundation have been established
- First donations set to arrive this week

STI In-House CLIA Waived Testing

- STI testing for Gonorrhea & Chlamydia is now available
- Staff training is in progress
- Policies and procedures are under development
- Integration with the Electronic Health Record system is ongoing

Dreamer Resource Center
