Housing Two Year Live on Requirement

- Request for Qualification (RFQ) is now out for local apartments within a 2-mile radius to respond to see if they are interested in being affiliated with Sacramento State. Over the years, housing has had local apartments contact them to be forge a partnership to provide housing for students. This RFQ is a step in the right direction to make a formal agreement with apartment complexes for the success of the students. This agreement will align with the current structure in housing by providing Resident Advisors and professional Residence Hall Coordinators to reside in the complex.
