Discussion was had on the memorandum of understanding (MOU) requirements as well as the eligibility requirements. Moved to amend language to state the MOU will be established no later than end of March 2025 and to be renewed every 3 years. Amendment was amended from March 2025 to April 2025 Adopted.
