 - President
 - o No updates given
 - **Executive Vice President**
 - Most accountability check-ins have been completed and there is a feeling that board members need to be reading their Rules of Operation more often. She is trying to find a middle ground between understanding the personal issues that affect board members' performance while also holding people accountable and making sure that they're doing the work that they were elected to do.
 - O She also expressed that the board is not utilizing their campus and ASI partners as much as they should, like SEO for example.
 - Sandra mentioned that there is an accountability concern that the EVP has to work on. She stated that the board members are taking warnings and strikes too personally and that they need to be done in a more direct way to avoid this issue. She mentioned that the EVP has to hold people accountable more since it is her ethical duty.

Output Vice President of Finance

- o The VPF mentioned that the Finance and Budget Committee is the strongest it's ever been at the moment.
- She is working on the Student Employment Grant.
- She also mentioned concerns with some of the board members not forwarding the SEED Information when she asked everyone to. This does not pertain to everyone on the board but a couple of members. The president and EVP mentioned that they will take care of issues like this and make sure that everyone is held accountable.

Vice President of University Affairs

- The VPUA mentioned that she's currently experiencing issues with board members contributing to events such as tabling. She stated that some people did communicate it to her if they weren't able to attend but there were board members that did not communicate anything.
- The president and EVP will be holding people accountable for these events as well.

Vice President of Academic Affairs

- The Board Secretary expressed difficulty with getting board members to sit on SMO.

- The EVP proposed the idea of changing the Rules of Operation to resolve this issue.
