- V. NEW BUSINESS
  - A. 2024/25-02-82/ Galinato, Hamdani Increase P.R.E. Scholarship Award
    The legislation was approved by the ASI Board of Directors on 2/5/25. The passed legislation aims to relaunch the Public Radio Experience (P.R.E.) Internship in partnership with CapRadio. Originally, the scholarship award for this program was \$500 per semester, but starting this summer 2025, ASI has increased the award to \$1,000. ASI's collaboration in this program demonstrates commitment to student success and professional development.
  - B. Student Employment Grant 2025-2026 Budget Review

The ASI Student Employment Grants (SEG) are funded through a 1994 referendum which states that a minimum of \$300,000 ASI funds are to be used to fund various programs across campus that employ students. The program has now evolved to split the funds between three divisions (Student Affairs, Academic Affairs, and Inclusive Excellence – now part of Office of the President) and they will be responsible of further distributing the funds to their own programs. At next week's meeting, we will share the number of programs per division, as reported by the divisions. The committee will have the opportunity to decide the overall grant amount for SEG FY25-26. The allocations per divisions will then be determined using *The Budhani Calculation*, which was explained to the members. H. Nguyen mentioned ASI should explore the possibilities of opening the grant to other divisions as well.

## C. Sign Conflict of Interest and Viewpoint Neutrality Forms

Every semester, both forms need to be completed by the committee members. M. Ruiz explained the contents of each form and how it plays a role when making financial decisions. It's important to always refer back to ASI's mission and if the ASI funding that's being voted on meets that mission. For the Conflict of Interest

form, the members are to disclose all affiliations where they have financial implications.

## VI. ANNOUNCEMENTS

W. Hamdani – One of my strategic priorities is to hold a financial literacy event and I am partnering up with Financial Wellness to host the event. The event will be on Feb. 25<sup>th</sup> from 12pm-2pm, join us for some pizza and fun activities. More details to come after my meeting next week with Financial Wellness.

Update on this topic, as of today, campus will no longer need to borrow funds from ASI. Jennifer Harris, Sac State AVP, was able to find an alternate funding source that qualifies to fund this cause. The newly found pot of funding is not student activity fees nor state issued funds. Thank you to ASI for your continued support.

**H.** Nguyen – Campus has announced the possible merging of certain Colleges, which means ASI might need to follow suit. Some Board members might be duplicating, as new positions open and roles overlap. More information to come at a later date.
