 - A. Proposed Legislations:
 - i. 2025/26 Kaur, Angulo, Kennedy, Maciel Revision to the ASI Election Code: Expenditures Cap

Legislation was opened for further discussion from last F&B meeting on 9/16 to finalize recommendations. Committee members had the opportunity to ask clarifying questions. Chair, S. Maciel, explained in detail all of the expenditure caps suggested per the legislation. After deliberate consideration, below are the detailed approved recommendations from the committee:

- Individual: no change to the election code, expenditure cap to remain at \$350, as recommended by counted votes of ten in favor and one to increase to \$450.
- Presidential Ticket: no change to the election code, expenditure cap to remain at \$500, as recommended by counted votes of six in favor, two votes to increase to \$650, and one abstain.
- Slate: expenditure cap recommended shall be limited to \$250 per candidate in a slate or until maximum slate cap of \$800 is reached (maximum of 6 candidates per slate), as decided by 11 counted votes in favor and zero against.

Committee voted by unanimous decision to table donation terms and decisions until the Election Planning Group does further research.

After the listed approved recommendations from the committee, the legislation will be presented to the Board for final approval.

ii. 2025/26 - Maciel - Revision to the ASI Election Code: ASI Elections Grant

The committee decided to table the legislation for further discussion at next meeting on 9/30/2025 by majority of counted votes, 11 in favor and zero against.
