# A. Election of Finance & Budget Committee Vice Chair

Members interested in the position nominated themselves via email. There were three interested members, however, one of them withdrew their application. Nominees – H. Elyasi and M. Baltazar were given one minute to deliver a pitch to the voting members to make a decision between the two. Twelve present voting members voted anonymously via an online ballot. ## C. Proposed Legislations:

i. 2025/26 - Maciel - Revision to the ASI Election Code: ASI Elections Grant

Chair introduced the legislation and the updates to the Election Grants to fourteen separate grants of \$150 each. However, Chair, decided to present an alternative to the proposed legislation. The options listed below were presented to the committee as alternatives to explore:

- a. Fourteen grants at \$150 each
- b. Candidate starter kits for about 30 candidates, which include necessary supplies to fund a campaign and a credit with University Print. The kit value and printing credit will be further evaluated and determined by EPG and previous candidate's expenses.
- c. Mixture of both grants and starter kits.

Two counted votes wanted to explore option c. However, by ten counted votes, the committee decided to move forward with option b. Further research will be done and a revised legislation will be presented at next meeting.

ii. 2025/26 – Maciel – Revision to Operating Rule 400.3 Dollars for Organizations and Clubs (DOC) Funding Guidelines

Chair and DF presented the legislation updates regarding cap increase to \$2,000 and other edits to the language for clarification purposes. Additionally, once the limit is reached, funding will cease until a minimum of \$800 in DOC is used. Updates will be effective immediately to remain in compliance with funding guidelines.

The committee, by twelve unanimous counted votes, decided to approve the legislation and recommend to move forward and present to the board next for final approval.
