  - b. [AB 1002 – \(Choi\)](#) Postsecondary Education: Course Credit for Prior Military Education, Training, and Service
    - i. Motion to support AB 1002 by Noah, seconded by Samantha
    - ii. Discussion- AB 1002 requests that the University of California system and the California State University system mimic the California Community College system’s policy implementation to review and create transferable credit from Service Member’s Joint Service Transcripts. In 2018, the legislature passed SB 1071 by Senator Roth creating a method for CCC to recognize the Joint Service Transcript (JST) for transferable credit into degree paths. Since the implementation, the CCC has taken the steps necessary to implement this law. With degree paths identified and transferable credit granted, service members and veterans are receiving credit for the education and experience they have already accomplished and proved. Unfortunately, the UC system and CSU system has not requested to participate in the JST transferability. Through AB 1002, veterans and service members will receive their due credit by our centers of higher learning that they have earned during their military service.
