## VI. DISCUSSION ITEM: UNIT CAPS ON SUMMER SESSIONS

Student Feedback:

- -Limit those who have DFW on transcript
- -Unit cap could be done, but not now
- -Unit cap would limit students
- -Proposed 8 unit cap (APC)
- -Concern with accessibility to advisors especially in a virtual environment
- -Doesn't seem to be a concern at the moment with such a low DFW rate (based on data presented)
- -"Does petitioning limit your ability to register for classes if not approved in time?"
- -"What's the issue?"
- -Advise students on what a high unit summer course load would mean. Student Academic Senate Consensus
- -Do not limit those who are doing well, but place a unit cap for those who are on academic probation
