2024/25-10-34/ Andrade-Dominguez, Conejo Gallegos – Resolution in Support of University Hour at Sacramento State

Shared that this is an hour that is dedicated to not having classes and having engagement with students on campus through various activities. It was shared that there are logistics that still need to be taken into consideration and those conversations are underway. There will be a taskforce assembled to work out the logistics of this initiative. This resolution is simply to support the initiative itself. It was suggested to add ASI to participate on the taskforce in the resolution.

2024/25-10-35/Andrade-Dominguez – Resolution in Support of Enhancing Resources for Latine Students

It was shared that Gabriel Conejo Gallegos' name needs to be added to the legislation. It was shared that this is a legislation that has taken into consideration student input to increase resources for Latine students on campus. It was asked if a taskforce would be assembled for this initiative. The Hispanic Serving Institution (HSI) Director has been hired and would be the individual to lead those efforts.

2024/25-10-36/ Hamdani, Galinato, Kemp – Operating Rule Change 200.6 – Recall Election Procedures

It was shared that there is a current requirement for social security number to be provided to initiate a recall of the elections process. This legislation recommends to change the requirement from social security number to a Sac State student ID number for safety, security, and accessibility reasons. It was suggested to add specific Board members to the author list. Suggestion was made to make clear that the Vice President of Student Affairs (VPSA) VPSA would be the one to vet the merit of the recall. Context was provided on why the initial requirement was a social security as that used to serve as a student's identification number years back. The recall process was shared and discussed.

2024/25-10-37/ Conejo Gallegos, Andrade-Dominguez – Resolution Opposing the Current Time, Place, and Manner Policy and Calling for a Task Force to Develop a Statewide Policy

Discussion was had on whether this would hinder ASI's relationship with the University. It was shared that discussion was had with the Vice President of Student Affairs (VPSA) to ensure accuracy of the resolution and further strengthen it. It was added that students have asked that their feedback and input be added to address these policies. The resolution is calling for a taskforce and is not a statement that Sac State has done anything incorrectly. This is a systemwide movement.
